EMB MC 2020-31 Five-Year Validity of ECC

- Updating provisions of DAO 2003-30 (ECCs of projects not implemented within 5 years expire)
- Required to update baselining & monitoring
- Project is deemed implemented when:
 - Started "site clearing" construction/installation of project facilities.
 - Construction of fences (and other security enclosures) is not considered start of project implementation.
- Identified list of required documents for ECC Extension


Minor ECC Amendment Documentary Requirements

- Ease of Doing Business and Efficient Government Service Delivery Act of 2018
- To facilitate non-technical minor amendment of ECC
 - ✓ Change of Project Name / Trade or Business Name
 - ✓ Change of Proponent/Company Name
 - ✓ Transfer/Change of Ownership
- ECC Minimum Documentary Requirements

- Basis of denial
 - ✓ Misrepresentation
 - ✓ Inappropriate attachment/s
 - ✓ Invalid proof of payment
 - Environment-related complaint/s not addressed by Proponent

- Online processing fees
 - ✓ New ECC Application: P5,070.00
 - ✓ECC Amendment: P2,030.00
 - ✓ Denied applications with posted payments may still use the same payment within the same calendar year

Interim Protocols on the Conduct of Remote Site Inspection

- Use of remote technologies in the conduct of field monitoring, validation, inspection, and other field activities
- Protocols
 - ✓ Online Platform/s
 - ✓ Notice to Conduct Site Inspection (at least 7 days)
 - ✓ Test run of platform prior actual inspection date
 - Entry meeting / conference (purpose, areas covered by inspection, restriction if any)
 - Exit meeting / conference (summary of findings, timeline of correction actions)
